## Release From Liability and Indemnity Agreement

I, being of lawful age, in consideration of being permitted to enter into or use the facilities of the Capitol City Rifle Club, Inc., do for myself, my spouse, family, guests, legal representatives, heirs and assigns, hereby release, waive, and forever discharge the Capitol City Rifle Club, Inc., its agencies or departments, its officers, members in their official and personal capacities, their heirs, administrators and executors and executor, from all liability of any nature whatsoever, for any and all loss or damage, and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or equity, arising from or by reason of death, or any bodily injury or personal injuries known or unknown, or property damage resulting or to result from any incident which may occur directly or indirectly as a result of my use of the facilities or any activities held thereon, whether caused in whole or in part by negligence of club or otherwise.

I further specifically release the releasee, and its officers, members, and Board of Directors, officers, agents, and employees in their official and personal capacities, from any claim whatsoever on account of first aid, or other medical treatment rendered to me as a result of my attendance at Capitol City Rifle Club range activities.

I agree to indemnify the releasee for any and all expenses and liability incurred as a result of my use of the Capitol City Rifle Club range facility including but not limited to actual attorney fees, other litigation costs and any judgments.

I agree to take full responsibility for my guests and to indemnify the releasee for any and all expenses and liability incurred as a result of my guests' use of the Capitol City Rifle Club range facility including but not limited to actual attorney fees, other litigation costs and any judgments.

I agree that this release constitutes the entire agreement between myself and the releasee and its Board of Directors, officers, agents and employees and the terms of this release are contractual and not a mere recital.

I agree that this release agreement is intended to be as broad and inclusive as permitted by law and that if any portion of it is held invalid, the balance of it will, notwithstanding, continue in full legal force.

I am aware that there are certain dangers and risks inherent in participating in the shooting sports, and I do hereby agree to assume such risks, as provided in Michigan Compiled Law 691.1544:

“Each person who participates in sport shooting at a sport shooting range that conforms to generally accepted operation practices, accepts the risks associated with the sport to the extent that the risks are obvious and inherent. Those risks include, but are not limited to, injuries that may result from noise, discharge of a projectile or shot, malfunction of sport shooting equipment not owned by the shooting range, natural variations in terrain, surface or subsurface snow or ice conditions, bare spots, rocks, trees, and other forms of natural growth or debris.”

This release is given to induce the releasee to accept my application to participate, and to allow me to participate, in the Capitol City Rifle Club range activities and for general use of the range as permitted by the Capitol City Rifle Club Board of Directors.

I have carefully read this release and understand all of its terms. I execute it voluntarily, and with full knowledge of its significance. I understand that this properly executed release must be in possession of the Capitol City Rifle Club before I will be given permission to use their range. Beginning in January 2006, annual dues are \$60.

CAPITOL CITY RIFLE CLUB  
**RANGE RULES**

1. When people are down range, back away from the bench, and **DO NOT** handle firearms.
2. Keep gun unloaded and action open until ready to use.
3. Always point the muzzle in a safe direction and not raised above the horizon (except trap).
4. Keep your finger off the trigger until you are ready to shoot.
5. Firearms may not be handled after consuming alcohol.
6. Use target frames and boards that are provided. Do not post targets on support posts.
7. Do not place targets on the ground.
8. Use only paper targets. No unauthorized targets (cans, bottles, bowling pins, etc.).
9. All MEMBERS and GUEST SHOOTERS must sign in and sign out in the book provided.
10. Always wear eye and ear protection when on or near any firing line, or as a spectator.
11. Discharging of fully automatic capable firearms is **NOT** allowed.
12. The club's target thrower only must be used for all shotgun shooting into the air. Does not apply to paper targets for sighting in.

CAPITOL CITY RIFLE CLUB  
**GUEST POLICY**

1. Members are permitted to bring **TWO** guests per day.
2. Members are to make guests aware of the range rules.
3. The member will assume the responsibility of Range Safety Officer and instructor.
4. Members must supervise guests at all times and will not leave them unattended.
5. Guests are limited to shooting 100 rounds only per day.
6. Guests must be known to the member. No member is to let an unknown, non-member into the range to shoot.  
*Any guest interested in doing more than is allowed, is encouraged to become a member and take the orientation.*
7. A member may bring any number of bring his/her immediate family (spouse, parents, siblings and minor children only) to the range.
8. The member must be present at all times.
9. Members are to make all family aware of the range rules.
10. Family members are not limited to the amount of rounds fired.
